

## Information on the processing of personal data

In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter "RODO"), Jagiellonian University informs that:

1. The administrator of your personal data is Jagiellonian University, 24 Gołębia Street, 31-007 Kraków, represented by the Rector of the Jagiellonian University.
2. Jagiellonian University has appointed a Data Protection Inspector, 4 Czapskich Street, 31-110 Kraków, room no. 27. The Inspector can be contacted by e-mail: iod@uj.edu.pl or at telephone number 12 663 12 25.
3. Your personal data will be processed for the purpose of conducting the Test Of Proficiency In Korean (TOPIK) in connection with the bilateral agreement between Jagiellonian University and the National Institute for International Education (NIIED) under the Ministry of Education of the Republic of Korea on the basis of Article 6(1)(a) RODO and Article 49(1)(a) RODO, i.e. your consent.
4. Your provision of personal data is voluntary but necessary for the examination to take place. The consequence of not providing personal data will be that you will not be able to participate in the aforementioned examination.
5. Your personal data in the following areas: name and surname, address, date of birth, telephone number, email address, gender, nationality, profession, image will be provided to the Embassy of the Republic of Korea in Poland based on your consent, i.e. Article 49(1)(a) RODO.
6. Your personal data will be transferred to third countries (outside the European Economic Area - Embassy of the Republic of Korea on the basis of Article 6(1)(a) RODO and Article 49(1)(a) RODO - i.e. on the basis of your consent to the transfer of data due to the lack of a decision establishing an adequate level of protection and the lack of adequate safeguards. The Jagiellonian University informs you that in the aforementioned case the data are transferred outside the European Economic Area, where neither the provisions of the RODO nor the decisions referred to in the RODO apply. The above indicates that there is an increased risk of a breach of the transferred data. The controller will make every effort to ensure that the obligations incumbent upon it are carried out with the utmost care.
7. Your data will be processed and stored by the Jagiellonian University only for the duration of the procedure related to the TOPIK examination, i.e. until 31.12.2022, and will then be deleted.
8. Once your data have been provided to the Embassy of the Republic of Korea on the basis of your consent (Article 49(1)(a) RODO), to the extent that the data have been provided - the Embassy of the Republic of Korea becomes a separate controller.
9. You have the right to: to be informed about the processing of your personal data and your rights under the RODO, to access and rectify the content of your data, and to have your personal data deleted from the controller's files (unless further processing is necessary for the performance of a legal obligation or for the establishment, investigation or defence of claims), and to have the right to restrict processing, to data portability, to object to processing - in the cases and under the conditions set out in the RODO.
10. You also have the right to withdraw your consent at any time without affecting the lawfulness of the processing carried out on the basis of your consent prior to its withdrawal. You can send your withdrawal of consent to the following email address: sekretariat-orient@uj.edu.pl or by appearing in person at the IBiDW, 2a Oleandry Street, 30-063 Kraków. The consequence of withdrawal of consent for the processing of personal data will be the inability to participate in the aforementioned examination.
11. Your personal data will not be subject to automated decision-making or profiling.
12. You have the right to lodge a complaint to the President of the Office for Personal Data Protection if you consider that the processing of your personal data violates the provisions of the RODO.
