Jonathan Floyd is Associate Professor in Political Theory at the University of Bristol. He has written widely on questions of methodology in political philosophy and is the author of *Is Political Philosophy Impossible?* (Cambridge University Press, 2017) and *What's the Point of Political Philosophy?* (Polity, 2019). He is also Founding Chair of the recently formed 'Methods of Normative Political Theory' Standing Group within the European Consortium of Political Research (ECPR).

His recent work in developing the theory of 'normative behaviourism' was the subject of a conference in 2021 funded by the Political Studies Association (PSA), with a special edition of *Political Studies Review* based on the papers presented at that event later published in early 2023. A second conference, to be held at the University of Roskilde in 2023, and planned special edition on the same theme for 2024, funded by the ECPR, is now in progress. His current work in producing political philosophy's first monograph on 'methods and methodology' (under contract with Oxford University Press for 2024), will be the subject of three separate workshops in 2023, as hosted by the universities of Helsinki, Maastricht, and Münster.

Ben Gidley studied Anthropology as an undergraduate and Urban Studies at the MA level and has a PhD in Sociology (on citizenship and belonging among East London Jewish radicals in the early twentieth century) from the University of London. He is a Reader in Sociology and Psychosocial Studies at Birkbeck, University of London. Before that, he worked in interdisciplinary urban studies and migration research centres at Goldsmiths, University of London and the University of Oxford. During that period, he was involved in several policy-engaged research projects on topics around migration, integration and diversity, funded by research councils, charitable trusts, government departments and the European Union.

Ben's research is largely centred around the question of how we live together with difference in urban contexts. He also has an interest in British Jewry; *Turbulent Times* (Bloomsbury, 2010), written with Keith Kahn-Harris, was the first sociological monograph on British Jews for several decades, and on understanding different racisms comparatively; *Antisemitism and Islamophobia in Europe* (Palgrave, 2017), co-edited with James Renton, was a breakthrough volume in this field.

He is now leading the transnational ORA research project ENCOUNTERS: Muslim-Jewish encounter, diversity and difference in urban Europe, whose first publication is the book *Jews and Muslims in Europe: Between Discourse and Experience* (Brill, 2022), co-edited with Sami Everett.

Olaf Glöckner, PhD, is a researcher at the Moses Mendelssohn Centre for European-Jewish Studies in Potsdam (MMZ). Glöckner's main foci of research are on Jewish Migration, European Jewry after 1989/90, German-Israeli relations and modern anti-Semitism.

Glöckner has worked and participated in several empirical studies on Jewish migration, Jewish education, and Jewish experiences with modern anti-Semitism (incl. the AS Studies of the Fundamental Rights Agency 2012/13 and 2017/18). Currently, he is involved in the EU-funded project "United in Diversity" – An Interdisciplinary Study of Contemporary European Jewry and its Reflection" and in the joint research project "ASJust – Struggling of the Judiciary in Germany with anti-Semitism".

Dr Serena Hussain is a Sociologist and Human Geographer. She is currently an Associate Professor at the Centre for Trust, Peace and Social Relations. Serena completed her PhD in Sociology at the University of Bristol and went on to obtain an ESRC Research Fellowship in Geography at the University of Leeds. She then held a Post-Doctoral Fellowship at the University of Oxford, where she remained a Visiting Senior Research Associate in the School of Geography until 2013. Before joining the Centre for Trust Peace and Social Relations, Serena acted as the Principal Scientist on International Migration at Charles Darwin University in Australia. Serena has worked as an expert consultant for a number of British government departments, with organisations such as Ipsos MORI and the BBC World Service; and collaborated with academics from the US, Asia and Australia.

Some of her current research explores;

- Transnational Capital among migrant youth in the UK, Australia and Canada with Deakin University, funded by the Australian Research Council;
- Engaging the public in Census 2021, funded by UKRI;
- and Peacebuilding interventions in fragile contexts with Islamic Relief Worldwide, funded by SIDA.

Serena currently supervises eight PhD students, is the Editor for a Springer book series, and a member of the editorial board for the journal Migration Letters. She is also a member of the Kashmiri Scholars Consultative and Action Network; and an Adjunct Professor in the Department of Politics and International Relations, Quaid-e-Azam University, Pakistan.

Her research interests include Jewish and Israel Studies, precisely the quality of life of contemporary European Jewish communities in the context of a sense of belonging, transnationalism, and antisemitism. In the field of Israel Studies, her research interests combine Mizrahi Studies, ethnicity, and gender. Recently, she has focused on Jewish-Muslim relations from a transurban comparative perspective.

Marcela (co-)authored and (co-)edited several monographs and articles, e.g., "Jews and Muslims in Dubai, Berlin, and Warsaw: Interactions, Peacebuilding Initiatives, and Improbable Encounters," together with Joanna Dyduch and Olaf Glöckner. *Religions* 13, no. 1: 13. or *Being Jewish in 21st Century Central Europe*, published in De Gruyter. She is a principal investigator of the ongoing cooperative research project: *Jews, Muslims, and Roma in the 21st Century Metropolises* that involves partners from Potsdam and Jagiellonian universities, and she is a member of an international research team led by Artur Skorek (Jagiellonian University): *Jewish and Muslim Minorities in Urban Spaces of Central Europe*. Marcela is an academic council member (2020-2022) and vice-president-elect (2023-2026) of the European Association of Israel Studies.

Tariq Modood is a Professor of Sociology, Politics and Public Policy and founding Director of the Centre for the Study of Ethnicity and Citizenship at the University of Bristol and the co-founder of the journal, *Ethnicities*. He has held 40+ grants and consultancies, has 35+ (co-)authored and (co-)edited books and reports and 280+ articles and chapters. He was ranked #131 in the world (#19 in the UK) in the Research.Com citations 2022 ranking for Law, Politics, Sociology and Social Policy.

His work is frequently cited by policy-makers and practitioners and, on several occasions, has influenced policy. He was appointed an MBE by the Queen for services to social sciences and ethnic relations in 2001, made a Fellow of the Academy of Social Sciences (UK) in 2004 and elected a Fellow of the British Academy in 2017. He served on the Commission on the Future of Multi-Ethnic Britain, the National Equality Panel, and the Commission on Religion and Belief in British Public Life.

His latest books include *Essays on Secularism and Multiculturalism* (2019), *Multiculturalism: A Civic Idea* (2 nd ed; 2013); and as co-editor *Multiculturalism and Interculturalism* (2016) and *The Problem of Religious Diversity: European Problems, Asian Challenges* (2017). His website is tariqmodood.com. He has supervised over 50 Ph.D.s and 10+ Research Associates and mentored 5 postdocs.
